

1) Applicant should have completed 18 yrs of his age

2) Should have accepted aims and objectives of the society

3) Should submit his application for membership along with his payment of fees. After acceptance of his/her application by the Executive Committee of the Society he /she should become member of the society.

4) The right to accept or reject the application for membership is exclusively reserved with Executive Committee for which no reason would be given.

5) Categories of Member -

1) Founder Members – The members signing this memorandum and officiating the first Executive Committee of the society would be termed as founder members that would have life membership. If any founder member expires or wishes to resign, his legal heir would be successor, such founder members should have paid the fees of Rs.200.00.

2) General Members - Any person who would pay Rs.101 as fees would be member of this class.

6) General body and its Function and Power -

1) Meeting of general body will be called once in a year.

2) Members of all the classes would be entitled to participate in this meeting.

3) This body would be the highest and final authority of the society for all decisions.

4) Would keep control over the work of Executive Committee of the society

5) To approve the accounts and to sanction the budget of the next year.

6) To approve or disapprove any subject with the permission of the chair.

7) To elect the managing committee.

7) Notice of the General Body Meeting and the Quorum -

Secretary of the Society shall issue the notice of such meeting, wherein all description regarding day date and time as well as Agenda of the meeting etc. shall be provided.

The presence of 2/3 of members is necessary for conduction of the meetings and in absence of such number of members. The deferred meeting can be held at the same place and day, immediately after postponing the meeting for an hour quorum will not necessary for the resumed meeting.

8) Special General Meeting and its powers:

Special General Meeting would be called after giving notice of 7 days, wherein, the issue to be decided would be regarding change in the name of the society, to add, amend or alter the aims and the objectives of the society, to amalgamate or to join with any other society and such other issues in the interest of society requiring immediate decision and action. 9) Tenure of Executive Committee and the period of election.

1. The tenure of Executive Committee shall be of 5 years.

3. The election would hold by secrete ballet paper or raising hands by the members present at the time of voting.

10) The Executive Committee of the Society-

There would be total 7 members in the Executive Committee, which would be as under

11) Officer bearers of Executive Committee and their powers:

President -

Being the head of the society, shall be responsible for all the activities of the society, to pass necessary order in the interest of the society, to keep control over the management of the society and all its branches.

Vice president -

In absence of president, to hold the office of president.

Secretary -

With the consent of the president, to carry out the following work.

- 1) To call General as well as Executive Committee Meetings.
- To look after the official correspondence of the society.
- 3) To look after the affairs of the society.
- 4) To look after the court work and legal complains
- 5) To check the daily accounts and to sign it after verification.
- 6) To supervise over the employees and solve their difficulties.
- 7) To sanction the bills and vouchers of the expenditure.
- 8) To carry out all the work in the interest of the society

Joint secretary

In absence of secretary, to hold the office of secretary.

Treasure -

To keep control over the financial affairs of the society and produce accounts with concern of secretary.

Prepare the budget, to deal with receipt and payments of the amounts as per the directions of the secretary, to do and cause to be done the compliance of all the objections raised by the Auditors.

Executives Members

To assist the above office bearers in the managerial affairs, to vote in the meetings, to remain present in all the meetings of the society.

Meeting of the Executive Committee and calling a Special meeting on Demand:

0

Within a period of one year, at least 4 meetings should be called upon, demand for callng of such meeting by1/4 majority of members. President should call a Special Executive Comnittee Meeting and upon his failure, such meeting may be called by the joint Signatures of any wo of such members demanding for calling such special Executive Committee Meeting.

Notice of the Executive Committee Meeting and the Required Quorum:

Secretary shall issue notice for calling such meetings to be served on the Members at least before 10 days of the meeting, wherein, shall also provide the Details of place, date and time of the meeting, along with the agenda etc. In such meeting, the presence of 2/3 rd members of the majority is necessary, however, in absence of such quorum, such meeting would be postponed for a period of one hour, thereafter, the postponed meeting can be held wherein, there would be no necessity for fulfillment of quorum.

14) Rules for holding of elections on Executive Committee-

- 1) Any member, who is in arrears of any amount payable to the society till clearance of such dues, would be having disqualifications to contest the elections for the Executive Committee or to remain in the office of the Executive Committee.
- Executive Committee should appoint the Retuning Officer for holding the elec-2) tions at least before 25 days from the date of completion of the tenure of the **Executive Committee**
- Notice of such elections should be issued to reach each voter members of the 3) society at least before 10 days of such elections.

For filling the vacancies in the Executive Committees -15)

All the application for resignation shall be presented before the President of the 1) Society.

Any application for resignation, letter so received should be put on the table of 2) the Executive Committee Meeting for its acceptance and till acceptance of such resignation, the concerned member would be holding his post.

Any post falling vacant as result of resignation, death or having incurred disquali-3) fication, shall be filled by nomination process by vote of majority for the remaining period.

Duties and powers of the Executive Committee-

To appoint, suspend, dismiss, terminate and regulate as well as control over the 1) employees of the society.

Bank Account of the Society can be opened in the name of Society with any scheduled or Nationalized Banks, Co-operative Bank, which can be operated by any two signature of President, Secretary or Treasurer.

Dealing with the immoveable properties -21)

The executive Committee of the Society can either purchase or sale any of the immoveable properties in the name of the Society, with the prior permission of the Assistant Charity Commissioner concerned.

Maintaining of Register of Members -22)

The names of all such members of the society shall be maintained in a Register, maintained as per Append 6 of section 15 of Societies Registration Act, 1860.

22-A) Provisions for effecting change in the name or aims of the society –

The change in the name or / and aims of the society can be effected, for which, action should be taken as per Section 12 and 12(A) of the Societies Registration Act 1860.

22-B) Provisions for effecting change in the Rules and Regulation of the society –

The change in the rules and Regulation governing the society can be brought of ¾ members of the society and the same can be made effective after it being approved by the Assistant Charity Commissioner concerned.

23) Regarding Disqualification from Membership -

- 1) The member, who has remained absent for three consecutive meetings, can be terminated from the membership.
- If any member is convicted by a court in any criminal offence involving moral turpitude would be liable for being removed from the membership of the society.
- 3) If any member is found to have indulged in misappropriation of the finance would be liable for being removed from the membership, but such a member may be given an opportunity to show cause by issuing such a notice in writing.

24) Maintenance of List of employees Cadre -

The list of the employees under the society shall be maintained as per Section 4 of the societies Regulation Act 1860 with the Assistant Charity Commissioner concerned.

25) Maintenance of List of Employees Cadres -

The list of the employees under the society shall be maintained as per Annexure – 2 of the societies Regulation (Maharashtra) Rules, 1971. The copy of this list should be submitted with the Assistant charity Commissioner concerned in the month of January of every year. Please see the annexed documents at Annexure – C

26) Regarding Closure of the Society -

By passing a resolution with 3/4th majority of members, the society can be closed/ dissolved however, for the said purpose, action has to be taken as per sections 13 and 14 of the Societies Registration act, 1860.
